- Q46. Statement: CMS Development. 1. System should work with interactive elements and allow staff the ability to easily update those functions.

- Q52. Statement: Quality Testing & Assurance. Deliverables. Relevant documentation related to web site access, usage and instructional material

 Question: What documentation "related to web site access, usage and instructional material" is included in the scope of this project? Are there any formatting regulations or standards the selected contractor must follow for the documentation?
- A52. Documentation should include any items verifying quality assurance testing, load times verifications, WCAG 2. 0 AA, accessibility compliance
- Q53. Statement: Project Management. Contract shall provide Project management services to manage and ensure completion of the project on schedule and within budget.

 Question: Are there currently any Project Management methodologies in place at SC Works Trident? Will the Project Sponsor, SC Works Trident Project Managers, and other stakeholders be available for project meetings hosted at the selected contractor's headquarters or via telecommunications?
